## 11 PAYMENT SYSTEM

### 11.1 [EUBF0712](#) = Reconciliation data for payment

Field of application:

Used for AO's reconciliation of surplus accounts, nominee accounts and trading book stock with respect to payments.

Sorting order:

1. AO
2. Office
3. VPC account
4. Type of payment (dividend, interest, etc)
5. Securities

#### **Tax types**

Three different tax types exist:

- Preliminary tax - withheld on revenues from Swedish securities to a private individual or estate with fiscal domicile in Sweden.
- Swedish coupon tax - withheld on dividend paid on Swedish shares to private individuals and legal entities with fiscal domicile outside Sweden.
- Foreign tax - withheld on revenues from foreign securities in accordance with the regulations prevailing in the the issuer's country of residence. In addition to the foreign tax, a preliminary tax up to 30% is withheld for private individuals and estates with fiscal domicile in Sweden.

For each separate yield, any of the following may occur: either no withholding tax, or a withholding tax type as described above, or two withholding tax types simultaneously, namely preliminary tax and foreign tax. This can be seen in the group WITHHOLDING-TAX.

#### **Currency converted amounts**

Where the issuer has chosen a different payment currency from the main currency (at present SEK), a recalculation is always made of all amounts to the main currency. The currency converted amounts are stored in the group CURRENCY-CONVERTED. The two tax amounts in the group correspond to the tax amounts in the group WITHHOLDING-TAX.

#### **Example**

Three examples are shown below – a dividend paid in Swedish kronor, an interest payment in euros and a dividend relating to an SDB (Swedish depository receipt) in Swedish kronor with the original dividend currency in US dollars.

## **11.2 AVVF081 = Notification of prize winnings, premium bonds**

### **From VPC**

Field of application:

Used for producing own reports, making own reconciliations, etc.

Further information:

The file contains details for the notification of premium prize winnings.

The file is normally available in the morning two bank days after reconciliation day.

Note that the file only contains information of prize winnings for nominee accounts, trading book stock and surplus accounts.

Record types include:
